# Friends of the Flitch Way and Associated Woodlands Trustees' Annual Report



The Trustees present their Annual Report and the Financial Statements for the year ended 30 March 2024. The Accounts comply with the current statutory requirements and with the requirements of the Statement of Recommended Practice (SORP).

# Constitution

The charity was constituted on 24th January 2006 and revised on 10th July 2006, 12th August 2014 and 3rd May 2019. The trust is registered as a charity under number 1115617. The registered address is 13 Keats Avenue, Braintree, Essex CM7 1HB.

# **Objectives and Activities**

In conjunction with Essex County Council (ECC) Country Parks Service, the Friends of the Flitch Way and Associated Woodlands work for the benefit of the public in the conservation, protection and improvement of the physical and natural environment of sites which may come under the management of the Essex Country Park Ranger Service. The aims are:

- To advance the education of the public in the conservation, protection and improvement of the physical and natural environment.
- To act as a channel whereby members of the public can give user feedback to ECC Country Parks Service.
- To carry out specific projects designed to enhance the facilities of the Flitch Way and Associated Woodlands subject to the approval of the site manager and the head of ECC Country Parks service.
- To work as part of the ECC Parish Paths Partnership opening up large numbers of overgrown rights of way throughout the county, replacing way markers, building bridges and improving access for everyone.
- To provide opportunities for members and supporters to meet and socialise

## **Achievements and Performance**

In the year 1 April 2023 to 31 March 2024, we were able to carry out similar activities to last year:

- 89 members and 43 active volunteers are recorded on our database.
- 3,745 total volunteer hours recorded from the Carriage Stewards, Flitch Way work parties and the Footpath work group, down slightly from 3,808.
- The Railway Carriage Museum was open for 248 sessions.
- We commissioned and installed a wooden sculpture in Garnetts Wood.
- We improved the Rayne Station area with assistance from the Booking Hall Café.
- We purchased benches with assistance from Little Dunmow, Takeley Parish Councils and Branson Leisure.

### **Financial Review**

The results for the year show our charity received income of £6,796 and had expenditure of £11,115 giving a net loss of £4,318. Further details are on page 3 of the Financial Report.
